Minnie K. Patton was one of seven children who grew up impoverished in Oklahoma and could not afford a formal education. When she married James Patton, a Dallas oil man, she established the Minnie K. Patton Scholarship Fund to ensure that others would not be denied an educational opportunity because they lacked the financial support.
